# Executive Officer's Report



The mission of the organisation continues to be to promote its health promotion services through the work conducted by its Self Help and Support Group members; ensuring their sustainability; continuing to add value to the sector and endeavouring to be considered a valuable partner by Government line agencies.

2012/2013 has been an astonishing year focused on building the resilience of our Self Help and Support Groups members and simultaneously ensuring that ConnectGroups addressed the ever changing face of the Social Services and Community sector.

A year that we launched The Pay It Forward Plan and the Self Help and Support Group Care Package, thanks to our partnership with the Mental Health Commission. The response and outcome from both projects were overwhelming, with over 40 groups and 20 individuals benefiting from them. It was the year that we worked unwaveringly with the (then) Department for Communities to negotiate and set our unit price, and successfully secured our five year funding contract. My special thanks go to Kay Channer (Program and Funding Officer Department of Local Government and Communities) and Jane Chilcott (Executive Manger Linkwest) for their guidance throughout the process.

It was a year that we were challenged by the implications of the launch of the ACNC, ensuring that our members were well informed as to the potential impacts it will have on them. It has also been a year where we prepared to celebrate our 30 years anniversary and for the first time, formally acknowledge those Self Help and Support Groups and individuals that have made a measurable difference in the lives of those facing adverse situations. It is the year we say goodbye to our Pier Street home that has served us well for the last 10 years. We farewell Linkwest and Clan WA who we have collaborated with, whilst sharing their wisdom and good practice.

It has been a year of excitement as we conducted a feasibility study and subsequently developed a Business Plan as part of our Social Enterprise "Hot Desk Community Hub" project.





Our thanks go to our Consultative Group, Members and Social Ventures Social Enterprise Consortium NGO's for their support. 2013/2014 will see us pilot the model. It has been a year when nothing has deterred us from our ability to continue to offer our core grass root services; whilst concurrently complying with the new sector reforms and for the Board and Management to continue to identify innovative ways to offer and expand our services in line with our key stakeholders needs.

It has been a year that life at ConnectGroups has been never boring or monotonous. I pride myself in the exceptional workforce and the calibre of the Board of Management. #### **Scope of Audit.**

The audit has been conducted in accordance with Australian Auditing Standards as necessary to provide a reasonable assurance as to whether, in all material respects, the Committee of Management and the **Connect Groups – Support Groups Association WA (Inc)** have complied with the Constitution of the Body and the relevant requirements of the provisions (to the extent applicable) of the Service Agreement.

Our procedures included examination, on a test basis, of evidence supporting compliance with the Constitution of the Service Provider and the requirements of the Service Agreement. These tests have not been performed continuously throughout the period and were not designed to detect all instances of non-compliance.

The Committee of the Service Provider is responsible for ensuring compliance with the terms of the Service Agreement, management resources and internal controls.

The opinion on compliance expressed in this report has been formed on the above basis.

#### **OPINION**

In our opinion the Committee and the Service Provider have substantially complied with the obligations imposed by the Constitution of the Service Provider and the terms and conditions of the Service Agreement. 

# Projects



## The Pay It Forward Plan - Supported by The Mental Health Commission

2012 saw the organisation put into place a project that had been negotiated with the Mental Health Commission in 2011. At the time ConnectGroups, with the Mental Health Commission, rotated around accessing funds and engaging in a brokerage role in order to address the 10% attrition rate of groups and to provide them with the goods and services that would ensure their sustainability and capacity building. Through this initiative, ConnectGroups could also directly liaise with Self Help and Support Groups and their members to ensure these grants have a positive impact on the mental well-being of their 'family'.



The outcome has been overwhelming with the organisation receiving a wide variety of submissions; including requests for room hire, professional assistance with strategic planning and becoming incorporated, funding a series of recovery workshops, promotional items and logo design, assistance with costs associated with team building days and facilitator training and even the publication of a poetry anthology created by individuals during their mental health recovery journey.

## Self Help & Support Groups Care Package - Supported by The Mental Health Commission

The Self Help and Support Groups Care Package was a study opportunity for ConnectGroups' members who were currently facilitating Self Help and Support Groups. Thanks to a grant received through The Mental Health Commission and in partnership with The Central Institute of Technology, ConnectGroups was able to offer 20 scholarships to members, which allowed them to undertake 6 foundation units. These 6 units have supported them in formalising their facilitation skills, and have gone towards a Certificate IV in Community Services. Seven will go on to complete the full qualification, once again thanks to the support from The Mental Health Commission and The Central Institute of Technology.

The 9th May 2013 saw the formal completion of the course and scholarship holders were presented with their Certificates of Completion. ConnectGroups congratulates all the scholarship recipients on their success and acknowledges their support and commitment for the initiative.

Some feedback from the participants:

*"The units on offer were extremely relevant, especially when dealing with individuals with mental health issues..."*

*"I have learned so much and can see so many applications for this learning for all the community groups I am involved with that it will keep me going for years!"*

*"I recently had an experience at my group where 5 new people arrived but no previous members turned up. I handled this with better self-confidence and self-belief than I would have done before this course."*

*"It feels great to be able to let my group know that I actually have training and experience!"*

*"Spending time with the rest of the class and learning about their situations had a positive impact on me. I learned a lot from my class members, as well as my lecturer."*





## Social Enterprise Study – Supported by The Department of Local Government and Communities

The State Government of Western Australia launched in April 2012 a \$10 million Social Enterprise Fund – Grants Program (SEF) aimed at increasing the number, effectiveness and efficiency of social enterprises in Western Australia by supporting the not-for-profit community sector organisations to establish new or strengthen existing Social Enterprises. Social Enterprises are organisations that:

*“are led by an economic, social, cultural or environmental mission consistent with a public or community benefit, trade to fulfil their mission, derive a substantial portion of their income from trade, re-invest the majority of their profit/surplus into the fulfilment of their mission.”*

ConnectGroups was successful in receiving a grant of \$41,000.00 to run a feasibility study. This study explored the possibility of ConnectGroups running a virtual office space or hot desk environment for Self Help and Support Groups that are currently working out of their homes and cannot look at leasing permanent office space. It was based on existing corporate and social return models based in the UK and Canada, based on offering above and beyond the actual office space at an accessible price.

This research was broken down into three phases:

**Phase 1** Focused on collecting the relative data that indicated that there was such a need.

**Phase 2** Conducted a real estate market cost analysis.

**Phase 3** Focused on the actual development of the Business Plan.

A comprehensive Business Plan was presented to the Social Enterprise Consortium and a request for seed funding was put forward in July 2013, which would see the trialing of the model. ConnectGroups thanks Jennifer Chaplyn from Same Page Consulting for her work and ability to comprehend the target market and Social Ventures for their guidance along the way.



## HAVoC Hope After Violent Crime - Supported by Lotterywest

The aim of this project was to investigate best practice models of Support Groups for people who have experienced the trauma of violent crime. Its purpose was to gain understanding and specific, local, contemporary knowledge of the most helpful and healing elements of effective support for victims. An initial review of the relevant literature indicated that peer support is a promising model for helping victims to regain hope after violent crime. Therefore, the peer support group project was named HAVoC.



Five peer Support Groups for victims of violent crime were the focus of the project. As different support methods and models have implications for efficient use of limited funds - for example, facilitator-led as opposed to mutual self-help groups - it was also anticipated that some comparison of the groups would occur. Although the nature of the project data did not permit such comparison, valuable information on physical, emotional and general wellbeing, and psycho-educational, emotional and social support provided by group membership was obtained.



In conclusion, the information gained from this project indicates that stronger focus on addressing physical wellbeing and quality of life issues has the potential to improve support outcomes for people who have been traumatised by criminal violence. The project findings have also demonstrated that the peer support group model can provide the emotional and social support needed for help, healing and hope for victims of violent crime.

November 2013 saw the official launch of the findings in the tranquil surroundings of Kings Park in the Place of Reflection.



# Out Reach Activities

## WA Regional and Rural

ConnectGroups endeavours to ensure that its regional and rural members are able to access those services available to its metro members. Two trips to the South West were organised as a means of identifying those local needs and to also provide the member groups information as to the organisation's priority areas. Both trips were well received and allowed the organisation to reinforce and build new partnerships. The road tour allowed for the organisation to develop new strategies as to how to best meet those identified needs which it will attempt to meet.

## Medicare Local - Gold Coast

ConnectGroups was invited to attend a Community Engagement Forum organised by the Medicare Local on the Gold Coast as a means of showcasing the organisation's service delivery model. The forum was attended by approximately 50 Self Help and Support Groups which gave us an opportunity to identify what their local needs and



wants were and compare them to WA. It was interesting to find that they are similar and that funding, training, insurance, meeting places and governance were top on their agenda for support. We were heartened by the fact that we have been able to address those needs in WA. However, work must continue if we are to ensure that our Regional/Rural members and those who are also physically isolated have access to the full range of our services. 2013/2014 will see us engage in the development of a new website and the delivery of training through webinars and online training.
